The Alumni Association will hold an election for the 1st IMC Alumni Manager.

The Alumni Association has appointed a Returning Officer to establish the "Procedures for Election for Alumni Managers of the Incorporated Management Committee", which is in accordance with the EDB's "Guide for Alumni Manager Election".

You are cordially invited to offer your candidacy for the 1st IMC Alumni Manager (The term of office should be one year). Election Procedures have been uploaded onto the Alumni Association's Website http://dlkpalumni.weebly.com/ for alumni's reference.

The Role of the Alumni Manager:

- 1. Developing the general direction for the College, formulating the educational and management policies of the College;
- 2. Overseeing the planning and budgetary processes, monitoring the performance of the College;
- 3. Ensuring the accountability of the school management and strengthening the community network;
- 4. Promoting communication and cooperation between the IMC and members of the Alumni Association of the College.

Nomination Procedures:

- 1. Alumni should complete the attached Nomination Form to nominate himself / herself, or a member of the Alumni Association at this College as a candidate; Nomination Form is also available in the College's General Office;
- 2. Candidates must be a member of the Alumni Association at this College, and they must meet the requirements as explained in the Election Procedures;
- 3. Period of nomination:
 - Thursday, February 23, 2017 to Wednesday, March 8, 2017;
- 4. Nomination deadline:

Wednesday, March 8, 2017 at 5:00 pm;

- 5. Completed Nomination Forms must be returned to the General Office in person or by post before the deadline (Nomination Forms returned by any other methods will not be accepted). The General Office will issue a notice of receipt for recognition for the Nomination Forms submitted in person while an email about notice of receipt will be sent to the alumnus for the Nomination Forms sent by post.
- 6. <u>Information submitted after the nomination deadline will not be accepted.</u>

Voting:

1. Voting period:

March 23, 2017 to March 31, 2017

- 2. Voting deadline: Friday, March 31, 2017, 5:00 pm
- 3. Method of returning ballot papers:
 - Alumni could return the ballot papers to the General Office in person within the above period (8:00 am to 5:00 pm, except Saturdays, Sundays and public holidays); or
 - by post to the General Office.
- 4. Ballot papers should be sealed in envelopes specifically designed for this purpose.
- 5. A vote counting session will be held on <u>Friday, March 31, 2017 at 6:00 pm</u> at the College's Room 109.
- 6. The results will be announced via the College Website and the Alumni Association Website on Wednesday, April 5, 2017.
- 7. If only one candidate is nominated, he/she will automatically be elected as the Alumni Manager; if more than one candidate, the one who obtains the greatest number of votes will be registered as the Alumni Manager.
